Once you create an account, you can access the readings for this course. This may seem difficult, but it is actually easy & it certainly saves you the expense of purchasing a course pack of readings.

There are 11 required readings from this reserve system. Each week there is an assignment from the course reserve list, you are to hand in through Canvas a one page, single space synopsis of the assigned reading. You may take ONE pass from this assignment (there are 11 articles- you need to hand in 10 assignments- but you need to READ ALL the pieces). These 10 assignments are worth 10 % of your grade. Grading

on the assignment is simple- you will either get a 1, a .5, or a 0. All I am looking for here is that you do the reading and give me both a summary of the article and an analysis of its content.

The take-home final will be a paper on a book of Florida fiction. You will get more information on that early in the semester.

## In-class recording:
